WWTP the clarifier is running hot and we are currently in the process of replacing it. The grinder motor in the head works is also running hot and beginning to fail. MCO recommends replacing the motor with another Bar Screen at the cost of \$4,300.00. The board agreed to have the motor replaced. Earl priced the cost to repair the large influent pump at the WWTP. \$7,300.00 is the price to replace the large pump and \$7,500.00 is the cost to repair the pump. The board agreed we would be better off replacing the pump. The project to replace the underground sanitary line on north Main Street is almost complete. The village has been told the bridge on north Main Street could be open as soon as Friday August 10, 2012. I & I still have 35 man holes to inspect. There has not been much progress on this due to the dry weather this summer. Public Works has been working with MCO to develop a sewer lateral ordinance.
