The meeting was called to order at 7:00 p.m. by President Collien.

Roll call found the following trustees present: Larry Ott, Tim Stoppleworth, Dan Redman, Al Kamenski, Dennis Steinke, Jim Eckberg, and Gary Collien. Also in attendance: Randy Much, Paul Much, Miriam Thomas and Tish Brooks.

Pledge of Allegiance

Public Works:

The snowmobile issue on East Church Street is being worked on. Possible solutions include putting up barricades or signs in cement buckets. Mr. Zimmerman is ok with anything that will prevent the snowmobiles from going on the sidewalk. Al will continue working with him on a solution.

Between 100-150 water meters will need to be replaced by 2014. Most of these are meters that were not recorded when initially installed. The outside meters are fine but the inside brass part that comes in contact with water will be replaced with a plastic part at a cost of \$45-\$50 per meter. Water loss is still around 30% and it is possibly due to the "new" meters reading low as well as the industrial meters at Seneca and the High School which MCO found out have been being read incorrectly. Dan stated they will be adding a totalizer to the industrial meters so only one reading instead of two will be necessary. Paul Much also said between reading the industrial meters correctly and the 150 "new" meters, water loss should come down considerably.

The sewer plant bypassing weekly limits were exceeded in April and May but it was due to additional clear flow and the lateral leak from an incorrectly installed line that has been fixed. Paul Much stated the DNR will not issue any citations because the exceedances were beyond our control.

Road repairs to the water main break areas as well as a few other spots will occur soon. Dan is getting estimates for crack filling.

Rademann has pulled some trees from the tree farm for planting or selling.
