The Oakfield Police Department is releasing the following information pursuant to Wisconsin State Statute 301.46(2m) which authorizes law enforcement agencies to inform the public about a sex offender when, at the discretion of the agency, the release of information will enhance public safety, awareness and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies.

This sex offender has served the sentence imposed on him by the courts.

THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR RATHER, IT IS OUR BELIEF THAT AN INFORMED COMMUNITY IS A SAFER COMMUNITY.

Sex offenders have always lived in our communities; but it was not until the Sex Offender Registration and Community Notification Law (ACT 440) was enacted that law enforcement was able to share this information with the community.

Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will NOT be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe the only person who wins if community notification ends are the sex offender, since sex offenders derive their power through secrecy.

The Oakfield Police Department has been notified by the Wisconsin Department of Corrections that Robert A Koenen is being released back into the Oakfield Community. Robert A Koenen was convicted in 2021 in Fond du Lac County Circuit Court on two (3) counts of Possession of Child Pornography and sentenced to 3years in prison. Robert A Koenen is on extended supervision until October 25, 2027.

Special conditions of Robert A Koenen's supervised release:

- 1) No unsupervised contact with minors, no contact with victim, not to consume drugs.
- 2) Comply with standard sex offender rules and cooperate with electronic monitoring.
- 3) Face-to-face contact with law enforcement required, comply with all requirements and lifetime registrant of Wisconsin Sex Offender Registry. He is required to comply with GPS monitoring for life.

Robert A Koenen will be residing at 382 Deer Trail Lane in the Village of Oakfield upon his release on or about October 22, 2024.
