10.12.010 All-night parking.

No person shall park or leave standing any vehicle on any street in the village of Oakfield for a period of time longer than thirty (30) minutes, between the hours of two-thirty (2:30) a.m. and six (6:00) a.m., upon any day between the first day of December and the following first day of April, both dates inclusive, except physicians or emergency vehicles on emergency calls. (Ord. 2001-19)

10.12.030 No parking at any time.

No person shall park or leave standing any vehicle at any time:

1. On the west side of Main Street, between Filby Street and Waupun Street. (Prior code § 4.03[3])
2. On the west side of North Second Street between Hubbard Street and East Church Street. (2007-10)

10.12.040 Parking for the primary purpose of advertising.

No person shall park or leave standing on any street in the village of Oakfield any vehicle for the primary purpose of advertising. (Prior code § 4.03[4])

10.12.050 Parking semi-tractors, semitrailers, trucks, and buses

A. No person shall park any semi tractor, semitrailer, truck exceeding five tons, or school bus on the streets in the village of Oakfield at any time except for loading or unloading and such time shall not exceed one hour.

B. Any person who shall violate any provision of this section may be fined not less than ten dollars (\$10.00) per day nor more than twenty dollars (\$20.00) per day for the first offense, and not less than twenty-five dollars (\$25.00) per day nor more than fifty dollars (\$50.00) per day for the second or subsequent offense within a year. (Ord. dated 11/9/83)

10.12.060 Restrictions on parking; posted limitations.

Forty eight-hour limitation. No person shall park or leave standing any automobile, truck, tractor, trailer or vehicle of any description on any public street or public parking lot in the village for a period of 48 or more consecutive hours in the same location at any time, except that where more restrictive parking limits have been established the more restrictive limits shall apply. When any law enforcement officer shall find a vehicle standing upon a public street or parking lot in violation of the provisions of this section, he is authorized to move such a vehicle or to require the operator in charge thereof to move such vehicle to a position permitted under this article. The law enforcement officer may cause said vehicle to be removed to a proper impoundment and storage area and in such case the owner shall pay the costs of removing said vehicle and the storage fees on said vehicle before he may recover the possession thereof (Ord. 2017-4).

10.12.070 Parking near Mailboxes

Except when necessary to avoid

conflict with other traffic, or in compliance with law or the direction of a police officer or official traffic control device, or momentarily to pick up or discharge a passenger or passengers, no person shall park a vehicle, whether occupied or not, within fifteen feet of a public or private curbside mailbox between the hours of eight a.m. and five p.m. (Ord. 2017-4).

10.12.080 Street Storage and parking of recreational vehicles

A. Definitions. Recreational vehicle means any of the following but limited to:

Travel Trailer. A vehicular, portable structure built on a chassis and on wheels; that is, between 10 and 36 feet long, including the hitch, and 8 feet or less in width; designated to be used as a temporary dwelling for travel, recreation, vacation or other uses and towed by a car, station wagon or truck. It includes so-called fifth-wheel units.

Pick-up Coach. A structure designed to be mounted on a truck chassis for use as a temporary dwelling for travel, recreation, vacation or other uses.

Motor Home. A portable, temporary dwelling to be used for travel, recreation, vacation, or other uses, constructed as an integral part of a self-propelled vehicle.

Camping Trailer. A canvas or folding structure mounted on wheels and designed for travel, recreation, vacation or other uses.

Chassis Mounts, Motor Homes and Mini-Motor Homes. Recreational structures constructed integrally with a truck or motor van chassis and incapable of being separated therefrom.

Converted and Chopped Van. Recreational structures that created by altering or changing an existing auto van to make it a recreational vehicle.

Boat. Every description of watercraft used or capable of being used as a means of transportation on water.

Boat, Snowmobile or All-Terrain, Utility Trailer. A vehicle on which a boat, ATV or snowmobile may be transported and is towable by a motor vehicle. When removed from the trailer, a boat or snowmobile, for purposes of this section is termed an unmounted boat or snowmobile.

B. Regulations

1. The temporary parking of a recreational vehicle within a street front yard shall be allowed for the purpose of loading or unloading, washing or general maintenance, for a period not to exceed 48 consecutive hours pending the size of the recreational vehicle and it does not exceed the normal width of average vehicle to allow traffic to flow in both directions.
2. At no time shall a recreational vehicle be used for permanent living, sleeping, materials storage or other purpose.
3. No recreational vehicle shall be permanently connected to water, gas electric, or sanitary sewer.
